

HYBRID WILDERNESS FIRST RESPONDER RECERTIFICATION (HWRR)

COURSE DESCRIPTION

Hands-on, meet online. Enjoy our newly formatted WFR Recertification, which includes an online component in addition to the traditional scenarios and skills. Pre-work allows you to review the curriculum at your own pace, and focus on the hands-on element during your two days on course. You'll just need to complete all online components, including a written exam, prior to the course. Once on course, the scenario-based approach to recertification provides you the opportunity to test your skills against realistic situations. You'll practice and relearn wilderness medicine protocols, review evacuation and decision making guidelines, and receive the latest updates in wilderness medicine over the course of two days.

Students must successfully complete the online modules prior to arriving at the course. Students will then demonstrate their practical skills during scenarios throughout the in-person portion of the course. Students must successfully complete both components to pass the course and obtain recertification from NOLS Wilderness Medicine.

There are optional review resources (different from the online modules) found on the Wilderness Medicine Resources page.

Upon successful course completion you will earn the following NOLS Wilderness Medicine certifications: Wilderness Advanced First Aid/Wilderness First

Responder/Wilderness EMT (dependent on your current certification), Adult and Child CPR & Airway Management, and Epinephrine Auto-injector.

CLASS FORMAT AND PERSONAL PREPAREDNESS

This newly formatted WFR Recertification course includes an online module component. Upon registering, you will receive an email with further information. Three weeks prior to the start of the course you will receive an email with links to online materials (readings and videos) and the written WFR Recertification test.

You must complete all online components prior to arriving at the course site. Please note that these online resources are different from the review materials available on the NOLS Wilderness Medicine website.

Check-in is at 7:45 AM on the first day of the course. Course days run from 8:00 AM to 5:00 PM, with an additional evening class on the first day for students needing CPR recertification. Attendance is required at all scheduled classes. Scenarios and practice sessions will take place both inside and outside.

Bring outdoor clothing appropriate for lying on the potentially wet, muddy, snowy, or cold ground playing the role of both rescuer and patient. Frequently stage (moulage) blood and make-up are used to enhance the realism of a scenario. The classroom environment generally lends itself to a pair of comfy shoes or slippers and a camp chair.

REGISTRATION AND TUITION PAYMENT

Tuition payment in full is required to reserve your spot in the course. You can pay your tuition online (we accept Visa or MasterCard), by calling the NOLS Wilderness Medicine office with credit card information, or by mailing a check (with driver's license number).

The tuition fee includes instruction, textbooks, equipment use, certification, and continuing education credits.

A full refund will be given if we need to cancel the course for any reason.

WAFA/WFR/WEMT RECERTIFICATION REQUIREMENTS

NOLS Wilderness Medicine Graduates

NOLS Wilderness Medicine certification holders will be afforded a one-year period after expiration within which to recertify. This one-year re-entry period is only offered to those certified through NOLS Wilderness Medicine. Enrolled students must bring their certification card to the course so that the instructor can verify the expiration date.

Graduates from Other Wilderness Medicine Providers

NOLS Wilderness Medicine welcomes eligible graduates from other providers to recertify on our Wilderness First Responder Recertification course or our Hybrid Wilderness First Responder Recertification course. To be eligible for recertification you must possess a current (unexpired) WAFA certification, WFR certification from a provider whose WFR course is a minimum of 70 hours, or WEMT certification.

There is no re-entry period once your certification expires. It is your responsibility to make sure your certification meets this standard. If you are unsure, please contact NOLS Wilderness Medicine to verify your certification qualifies before enrolling in a course.

Students certified by other wilderness medicine providers are required to submit a photocopy of their unexpired certification card on the first day of the course. We cannot issue you a new card until we have verified your previous

training. Students recertifying the wilderness portion of their WEMT certification must submit a photocopy of their current EMT card on course.

NOLS WILDERNESS MEDICINE STUDENT AGREEMENT

Please download the **NOLS Student Agreement** and read it carefully as it affects your legal rights.

Bring the two-page signed document to the first day of the course. If you are a minor, a parent or guardian must sign the document as well. Without a signed document, you cannot participate in the course. NOLS Wilderness Medicine participants, including minors, will have unsupervised free time throughout the course. Any activities during the free time are not part of the NOLS Wilderness Medicine program and are at the sole risk of the participant.

Please download the GCCFLAssumption of Risk Form and please read this document carefully; sign, date, and bring with you to class. Additional copies will be onsite.

NOLS WILDERNESS MEDICINE POLICIES

Cancellations

Please notify our office as soon as possible should you need to cancel your registration. If you cancel more than 45 days prior to your class, you will receive a full refund less \$95.00 (per person). If you cancel within 45 days prior to your class, we must retain your entire tuition with no exceptions. Participants are strongly urged to purchase trip cancellation insurance through a travel agent. This insurance protects you against financial loss if you must cancel or interrupt a trip due to an illness or injury to yourself, a family member, or traveling companion.

Pets

Pets are not allowed at the course site. This includes leashing them outside. Any student bringing a pet to class will be asked to leave until the pet is safely situated in a kennel or other facility. No exceptions.

Service Animals

Alcohol, Drugs, Tobacco & Weapons

No alcohol, no drugs, no tobacco, and no weapons are allowed in the classroom.

CONTINUING EDUCATION

EMT Continuing Education

NOLS Wilderness Medicine is proud to be a Commission on Accreditation of Pre-Hospital Continuing Education (CAPCE) accredited organization. Current EMTs are eligible to receive 18 CEU hours for participation in a Wilderness First Responder course. Please bring a photocopy of your current EMT card(s) with you to your course.

COLLEGE CREDITS

Pre-Course Access to College Credit

The HWFR-R course is pre-approved for 1 credit through Western State Colorado University or an additional cost. Interested students must initiate registration and payment for credit by contacting Western at least 30 days prior to the course start. More information can be found here.

The HWFR-R course is pre-approved for one semester hour credit through the University of Utah for an additional cost. If you are interested in receiving college credit, please ask your instructors on the first day of class for the necessary information.

STUDENT LOGISTICS

Meals and Lodging

There is no meal and lodging package available for this class, therefore please pay particular attention to the following planning information.

Camping:	Get three nights deeply discounted camping at Mather Campground , in Grand Canyon Village, for only \$15 per person. (Nights of June 18, 19, and 20). Download the Campground Instructions & Reservation Form for more details and to book.

Getting Around:	There is a free in-park bus system that connects the campground with the historic district, where our classroom is found. Biking around Grand Canyon Village is a wonderful way of getting around due to the short distances between points of interest.
Food & Shopping:	Grand Canyon Village has a small grocery store located near Yavapai Lodge and the Campground where one can buy most staples. There are also numerous cafeterias and restaurants in Grand Canyon Village.
Recreation:	During your day off a day hike might be the order of the day. Look at Grand Canyon National Park's website for more details about the trails.
