COURSE DESCRIPTION

The Wilderness First Responder course is essential if you work or recreate in the outdoors or in other austere environments where access to medical care is delayed or communication is unreliable. It is the industry standard for professional guides, trip leaders, search and rescue team members, outdoor recreationists, and international travelers. Upon completion, you will be able to conduct a thorough physical exam, obtain a patient history, assess vital signs, provide emergency care in the wilderness, and make crucial evacuation decisions. During this fast-paced, engaging course, you will spend half your time practicing skills and participating in realistic scenarios, including a full-scale night mock rescue.

NOLS Wilderness Medicine's nationally recognized curriculum encompasses a wide range of topics including long-term patient care, wound management, selective spine immobilization, reducing dislocations, litter packaging, and epinephrine administration. Dynamic educators who have practiced medicine in both wilderness and urban environments will teach you skills and protocols to step forward in an emergency, and you will finish the intensive 80-hour course with the tools and confidence to manage patients in the backcountry for multiple days.

Upon successful course completion, you will earn the following NOLS Wilderness Medicine certifications: Wilderness First Responder, Adult, and Child CPR & Airway Management, and Epinephrine Auto-injector.

REGISTRATION/POLICIES

Tuition deposit of \$300 is required to reserve your spot in the course. Balance due 30 days before start date. Tuition is payable by check (with driver's license number), Visa/MasterCard/Discover/AmEx or cash. The tuition fee includes tuition, textbooks, equipment use and continuing education credits. WMI is not obligated to allow any student to attend a course until all WMI & TSS paperwork has been received, reviewed and approved. A full refund will be given if we need to cancel the course for any reason.

CANCELLATION AND REFUND POLICY

If a student cancels or withdraws from a course:

- ❖ Greater than or equal to 30 days prior to the course starting date, TSS will retain a \$50.00 administrative fee.
- ❖ Within 30 days of the course start date, tuition is non-refundable and non-transferable.

Pre-Course Access to College Credit

The WFR course is pre-approved for 3 credits through Western State Colorado University (WSCU) for an additional cost. Thirty days prior to the NOLS Wilderness Medicine course, interested students must initiate registration and payment for credit by requesting an enrollment form for WSCU from NOLS Wilderness Medicine. On-Course Access to College Credit

The WFR course is pre-approved for three semester hour credits through the University of Utah for an additional cost. If you are interested in receiving college credit, please inquire with your instructors on the first day of class for the necessary information.

FORMS REQUIRED FOR PARTICIPATION

Please download this agreement and read it carefully as it affects your legal rights: [WMI STUDENT AGREEMENT](#). Bring the two-page signed document to the first day of the course. If you are a minor, a parent or guardian must sign the document as well. Without a signed document, you cannot participate in the course. NOLS Wilderness Medicine participants, including minors, will have unsupervised free time throughout the course. Any activities during the free time are not part of NOLS Wilderness Medicine program and are at the sole risk of the participant.

CLASS FORMAT & EQUIPMENT

Check in is at 7:45 AM on the first day of the course. Course days run from 8:00 AM – 5:00 PM plus two evening sessions will be scheduled. Saturday is a day off. The format for this 80-hour WFR is classroom lectures integrated with practical scenarios, case studies, and skills practice sessions. Attendance is required at all classes. Scenarios and practice sessions will take place both inside and outside. Bring outdoor clothing appropriate for lying on the potentially wet, snowy, or cold ground playing the role of both rescuer and patient. Frequently stage (moulage) blood and make-up are used to enhance the realism of a scenario. The classroom environment generally lends itself to a pair of indoor comfy shoes and a camp chair. A 4-hour evening, outdoor mock rescue is part of the curriculum; dress accordingly. All course materials will be provided on the first morning of the course. Departure is after class on Wednesday.

Please come equipped with: a light day pack, notebook and pencil or pen, sunglasses and hat, clothing layers that allow you to be comfortable in a variety of weather conditions, water bottle, waterproof outerwear top and bottom, light hiking boots or sturdy shoes, headlamp and a watch with a seconds reference. (Optional: Slippers and camp chair for classroom time.) A 4-hour evening, outdoor mock rescue is part of the curriculum, so please dress accordingly.

❖ Students staying on campus will also need to bring a sleeping bag and sheet for underneath it, pillowcase, towels and personal items. Departure is after class on Wednesday.

ARRIVALS AND DEPARTURES

Participants staying off campus should arrive at 7:45 AM on Monday. Class will run from 8 AM – 5 PM Monday-Friday and Sunday-Wednesday, with 2 evening sessions; Saturday is a day off. Tuition includes lunches on class days. Departure is after class on Wednesday, at 5 PM.

Participants staying on campus must be at least 18 years of age & should arrive on campus on Sunday between 6-9 PM. Dinner is not available on site that night. Meals from breakfast on Monday through lunch on the last day of class and 10 nights lodging are included in course fee. Departure is after class on Wednesday. There are several taxi companies in the Jackson area in addition to Lyft and Uber. TRAVEL DIRECTIONS

Our Kelly Campus is located at 1 Ditch Creek Rd, Kelly, WY. **Please do not confuse this location with the Jackson Campus.** Parking at Kelly Campus is in the visitor lot, first lot on the left. Travel directions attached.

COURSE POLICIES

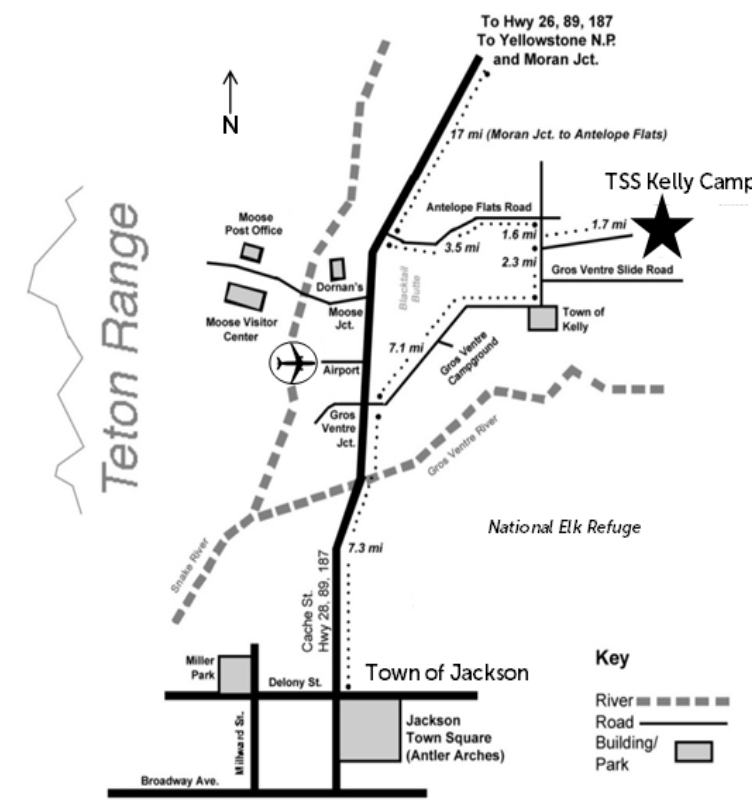
Getting to Jackson Hole, WY

By Air: Jackson Hole Airport (JAC) is 20 minutes from our campus and is serviced by American, Delta, Skywest, and United. You may also want to check rates and availability through Salt Lake City, Utah (a five hour drive to Jackson) or Idaho Falls, Idaho (two hour drive).

Car Rental: If you plan on renting a car before, during or after the course, Alamo, Avis and Hertz are available at the Jackson Hole airport. We recommend you make your car rental reservation in advance of the course.

By Car or Bus: If you are driving to Jackson Hole, there is free parking at the campus.

Driving Directions to the Kelly Campus:



1 Ditch Creek Rd, Kelly, WY 83011

From the north:

From Highway 26/89/187, turn LEFT onto Antelope Flats Road*. If you go as far as Moose Junction (Park Headquarters), you have gone too far. Once on Antelope Flats Road, drive approx. 3.5 miles to a crossroad and turn RIGHT. After approx. 1.6 miles you will come to the Teton Science Schools turnoff. There will be a small sign on the right. Turn LEFT. The school is approx. 1.7 miles up this road.

From the south:

From Highway 26/89/187, turn RIGHT onto the Gros Ventre Road almost immediately after crossing the Gros Ventre River. After approx. 7.1 miles you will see the town of Kelly (don't blink!) and the road will take a sharp turn to the left. From here it is approx. 2.3 miles to the turnoff for the Kelly Campus of the Teton Science Schools, marked by a small sign on the left. Turn RIGHT onto the school road and travel approx. 1.7 miles to our buildings.

*Antelope Flats Road is closed during the winter. If Antelope Flats Road is closed, continue south on Highway 26/89/187 for approx. 6.7 miles. Turn LEFT onto Gros Ventre Road and then follow the directions above for arriving from the South.
